RATES FOR PHOTOGRAPHIC REPRODUCTIONS

BASIC SCAN FEE

Reproductions of images in a digital file format. The following prices are in effect.

- \$20 per image (Production Fee);
- Administration Fee (shipping and handling: \$5 within Canada, \$10 outside Canada);
- Applicable Taxes.

In certain cases, the following extra fees might also apply:

- Usage Fee;
- Digital Support Fee;
- Priority Service Fee.

USAGE FEE

Type of Use	Extra Fee	Details

For Personal Use	No Extra Fee	<p>If you are using the images purely for personal purposes, such as for research, school projects, genealogies, non-commercial websites, or to offer as a gift, you do not need to ask for permission or pay a Usage Fee.</p>
For Exhibition and Scholarly Publication	No Extra Fee	<p>If you plan to exhibit the images publicly in a museum or interpretive centre, on an interpretive sign or plaque, or in a heritage or educational website, there is no Usage Fee to pay.</p> <p>If you plan to publish the images in a scholarly publication or in a publication of a non-profit organization, there is no Usage Fee to pay. However, the Victoria County Historical Society/Olde Gaol Museum must be visibly credited as the source of the image, and the credit line must include the image number of the photograph.</p>
For Commercial Publication	\$10 per image	<p>A usage fee is charged for publication of Victoria County Historical Society/Olde Gaol Museum images in books, magazines, CD or DVD-ROMs.</p> <p>Purchasing an image for publication gives you a non-exclusive license for one-time use, in all global jurisdictions in all languages.</p>

<p>For Audiovisual Use and other Commercial Use</p>	<p>Between \$50 and \$100 per image, subject to authorization by the Victoria County Historical Society/Olde Gaol Museum</p>	<p>A usage fee is charged for reproduction of Victoria County Historical Society/Olde Gaol Museum images in movie clips, films, videos. A usage fee is also charged for the use of Victoria County Historical Society/Olde Gaol Museum images as decoration in a public area, in advertisements, in commercial website, or on items for re-sale such as calendars, coffee mugs, postcards, t-shirts, etc.</p>

Upon receipt of a rush order, the Victoria County Historical Society/Olde Gaol Museum will fill it within 2 business days. These orders will be shipped by Canada Post's Regular Mail Service unless otherwise specified. The cost of Priority Service shipment will be billed to the customer. The Victoria County Historical Society/Olde Gaol Museum has the right to refuse Priority Service shipping for orders that it considers too bulky.

CONDITIONS OF USE – USAGE AGREEMENT*

Below is the wording of the Usage Agreement that will be sent to you if you pay a Usage Fee for Publication or a Commercial Fee with your photographic reproduction order. By paying these fees you agree to the following conditions of use:

USAGE AGREEMENT FOR DIGITAL IMAGE FILES*

1. Permission for publication is subject to your receipt of a copy of this agreement issued by an authorized agent of the Victoria County Historical Society/Olde Gaol Museum.

- Permission for publication is granted for the express purpose described in this agreement. This permission is non-exclusive. The Victoria County Historical Society/Olde Gaol Museum reserves the right to reproduce the image and allow others to reproduce the image.
- Permission granted terminates immediately upon publication or production of the Product.
- A Product produced simultaneously in more than one medium, such as a magazine published in both paper and electronic versions, is considered a single use for the purposes of this Agreement.
- Solely in connection with the marketing and distribution of the Product, the applicant may use the image on the packaging of the Product and in any advertisement, product catalogues, publicity or promotional use.
- Any subsequent use (including subsequent editions and adaptations, related Products, Web versions, etc.) constitutes reuse and must be applied for separately from Victoria County Historical Society/Olde Gaol Museum and will be subject to a Usage Fee.

2. The applicant assumes all responsibility under the terms of the Copyright Act for use made of images secured from the Victoria County Historical Society/Olde Gaol Museum.

- The Victoria County Historical Society/Olde Gaol Museum reserves the right to require a release from individuals whose privacy may be violated by the production of an image. Use of an image of an identifiable individual in a manner which suggests association with or endorsement of any product, service, cause or institution is prohibited.
- The applicant agrees to hold the Victoria County Historical Society and its agents harmless against any and all claims arising or resulting from the use of the material and shall indemnify the repository and its agents for any and all costs and damages arising or resulting from any such unauthorized use.

3. All use of images must include the artist's name, the Victoria County Historical Society's name and the accession number of the object in a caption or credit, except for films, in which the Victoria County Historical Society/Olde Gaol Museum's name must appear in the credits, but image numbers are not required.

- Credits should appear in close proximity to the image or in a special section devoted to credits. However, reproductions distributed electronically must contain the credit or caption as part of the image.
- The payment of a Commercial Use fee does not exempt the user from the credit line requirement.

4. Images supplied by the Victoria County Historical Society/Olde Gaol Museum may not be copied, scanned, exhibited, resold or used for any other purpose than that specified in this agreement. Copies shall not be deposited in another library, archives, or repository.

5. Unless approved in advance by the Victoria County Historical Society/Olde Gaol Museum, images shall not be retouched or altered in any way that could affect their historical or artistic integrity. If a detail of an image is to be reproduced, the word "Detail" must appear in brackets beside the accession number (or image number) of the image.

6. Prepayment of all fees, including Usage Fees, is required before permission is granted.

7. Reproduction is permitted only from digital files supplied by the Victoria County Historical Society/Olde Gaol Museum.

8. The personal information the Victoria County Historical Society/Olde Gaol Museum has collected for this Agreement is not used for any other purpose.

CONDITIONS FOR USING AND DOWNLOADING IMAGES FROM THE VICTORIA COUNTY HISTORICAL SOCIETY/OLDE GAOL MUSEUM'S WEBSITE

Digital images of artefacts in the database of the Victoria County Historical Society/Olde Gaol Museum website may be reproduced, distributed and transmitted to the public on the basis of the following "Creative Commons" criteria:

- Ownership. You must cite the name of the original author of this work.
- No commercial usage. You do not have the right to use this work for commercial purposes.
- No modification. You do not have the right to modify, transform or adapt this work.
